## **PRIVACY POLICY**

Your privacy is important to us. MM Kotkamills Oy and its subsidiaries (“MM Kotkamills”) undertake to protect your privacy and to comply with legislation on the processing of personal data and data protection. MM Kotkamills processes the stakeholder’s data it collects in accordance with the principles described in this Privacy Policy.

### **2**

#### **HOW WE USE YOUR PERSONAL DATA**

The purpose of processing your personal data is to maintain and develop customer or collaboration partner relationships to enable cooperation with various stakeholders and to fulfil contractual obligations, as well as marketing.

Our processing is based on our legitimate interest in managing customer and partner relationships and other stakeholder relationships.

We may also process personal data in order to fulfil our statutory obligations, such as responding to the authorities and in connection with legal claims.

#### **WHAT DATA WE COLLECT ABOUT YOU**

The personal data collected in the register is mainly information you or your workplace provided directly to MM Kotkamills. If data is collected from sources other than the data subject him/herself, we always request the data subject’s consent.

The data is stored in supplier and customer management systems on the basis of information provided by suppliers, customers and other stakeholder representatives themselves, as well as record entries of MM Kotkamills' personnel. The personal data we may process is listed below.

Only such personal data as is necessary for the purposes described above are entered in the stakeholder register. MM Kotkamills processes the following data:

Contact data

- First and last name
- Company and position in the company
- Company address
- Phone number, work
- Email address

#### WHO WE SHARE YOUR DATA WITH

In principle, we will not share your data. However, we may disclose personal data to authorities in order to comply with our statutory obligations.

Due to the technical implementation of the data processing, some of the data may be physically located on the server of an external subcontractor, from where they are processed by means of remote access. The data are collected in databases located on a secure server. The databases are protected by passwords and other technical means. The passwords required to access the register shall be issued only to persons authorised to use the register.

Information may be disclosed within the Group and when required by MM Kotkamills' statutory obligations. Disclosures are always made in accordance with data protection legislation. MM Kotkamills uses service providers who process personal data on behalf of and for the account of MM Kotkamills and to whom personal data is transferred to implement the service.

#### 5

#### WHERE YOUR DATA IS PROCESSED

Personal data is processed within the EU and the European Economic Area. If we also use service providers located outside the EU and the European Economic Area, we will ensure an adequate level of protection of your personal data as required by data protection legislation.

## 6 HOW LONG WE RETAIN YOUR DATA

In principle, data is retained for the duration of the stakeholder relationship. We may retain your personal data for longer than the duration of the stakeholder relationship if required by law, or if we need to retain the data for a reason such as litigation, accounting or dispute resolution.

## 7 YOUR RIGHTS

Your rights regarding the processing of your personal data are described below. You can request to exercise your rights, preferably by sending an e-mail to the controller using the request form.

*Right to verify your personal data.* You have the right to verify the personal data we hold about you.

*Right to correct your personal data.* You can ask us to correct any incorrect or incomplete data about you.

*Right to object to the processing of your personal data.* You have the right, on the basis of your specific personal situation, to object to the processing of personal data based on our legitimate interests. We evaluate such objections on a case-by-case basis. Please note that we may have the right to process personal data for a valid reason, despite your objections.

*Right to restrict processing.* In certain situations, you have the right to ask us to restrict the processing of your personal data, in which case we may only process your personal data with your consent, or for certain limited uses. You have the right to request a restriction on processing if the data we process is incorrect, processed unlawfully or unnecessarily, or if you have objected to the processing of your personal data.

*Right to delete data.* You have the right to ask us to delete data about you. We will process the deletion request, after which we will either delete the data or state a valid reason why the data cannot be deleted. Please note that we may have a statutory or other right not to delete the data you have requested.

Please contact us if you have any questions regarding the processing of your personal data or the exercise of your rights. We strive to resolve all issues related to the processing of your personal data with you personally. However, you can always file a complaint with the Data Protection Ombudsman if you feel that we are in breach of applicable data protection laws when processing personal data.
